BIOGRAPHY OF MR. GORDON BECKER of the UNITED WORLD FEDERALISTS, INC.

Mr. Becker was born in Amsterdam, New York in 1916 and after attending the local public schools he went to Amherst College where he graduated in 1937, magna cum laude, and supplemented this with 3 years at Yale Law School, from which he

S-1608 - A Bill to authorize the Secretary of the Interior to determine the valkdity of titles to lands acquired in the administration of the reclamation laws; without amendment

HR-5034 - An Act to authorize the taxation of Indiana land-holdings in the town of Lodge Grass, Mont., to assist in financing a municipal water supply & sewerage system

HR-3982 - A bill to authorize the Secretary of Agriculture to sell certain lands to the Sisters of St. Joseph in Arizona, Inc., of Tucson, Ariz., to consolidate the desert laboratory experimental area of the South-Western forest & range experiment station & for other purposes; without amendment.

HR-4646 - An Act to authorize the Secretary of the Army, the Navy & the Air Force to lend certain property to national veterans organizations, & for other purposes.

Comment: A letter can be written to the effect that U.S.Govt.should retain the title & put a tax on the land value in question only (NOT on improvements!

Comment: If the tax is placed on land values, it is a wise one. It would be advisable to put a flexible tax on the land they hold so that it will increase as the value of the land.

Comment: On this and the following two bills, all land in question can be treated the same way. A tax should be put on the land - title maintained by the Government.

HR-4895 - An Act to permit the prospecting, development, mining, removal, & utilization of the mineral resources within the Superior National Forest, Minn., & for other purposes: to the Committee on Interior & Insular Affairs.

All legislation on revenue has to pass the House of Representatives before it comes to the Senate, however, it might be worth while writing to the Committee on Finance in reference to George Legislation, uring elimination of all taxes on wealth & uring increasing taxes on land values.
