amendment if accepted at the polls in the coming election can be made of very much benefit to the cause of tax reform?

In the first place you are doubtless aware that our organization has in no way advocated the constitutional amendment which will come up at the polls next fall. The amendment supported by this organization was simply one to break down constitutional barriers and leave the legislature free to deal with the question of taxation in any way it might see fit. This amendment was adopted by the legislature last term but will have to be again adopted by the next legislature before it can be submitted to the people.

Most of our members regard the amendment which is to be voted upon by the people next fall as a makeshift which will delay rather than promote fundamental tax reform.

Your second question regarding the attitude of the Massachusetts Grange is one I am not able to anwer fully at the moment. I believe however that nothing worth mentioning has been done by our organization to reform the grange and so far as I know we have not been in touch with the Single Tax League of the Progressive State Grangers. Our movement in Massachusetts prior to two or three years ago was exceedingly merrin one and the awakening has necessarily been slow. Many desirable lines of activity have been discussed but effort has been possible only along a few lines so far.

I cannot find that the attitude of Representative Cross is known to any of our active workers.

As to capturing the machinery of the Progressive Party I am advised that earnest effort by able single taxers within the party were made to lead that organization along fundamental lines of tax reform but with very trifling success. A slight concession was made to the single taxers in the state platform two years ago but the state platform last year dodged the issue in spite of the fact that it was ably urged. The Progressive Party is so obsessed
