SITE VALUE TAXATION POTENTIAL FOR MISSOURI

The House Committee on Reassessment and Classification will hear testimony urging passage of House Joint Resolution 31, at 2:00 p.m., Tuesday, February 15, in Hearing Room B-7, State Capitol in Jefferson City. Co-sponsored by Rep. Walt Mueller, (R-Kirkwood) and Rep. Thomas Villa (D-St. Louis) and others, HJR 31 would amend the State Constitution to permit "Site Value Taxation" on a local option basis and could be adopted in any state taxing jurisdiction after voter approval therein.

"Site Value Taxation offers a key change in Missouri's real property tax structure," according to Mueller. "Under the concept, locations ("sites") could be taxed at a higher rate than buildings and improvements, thereon," he stated.
