Dear Fellow Georgist,

This is the time of year when I make an annual report to our members and I am glad to be able to tell you about another Real-World Victory:

• Pittsburgh moved once again to raise its land tax rate and lower its building tax rate. Without us lobbying, proposing rates and visiting city officials, there would have been no victory at all. If you contributed to HGFA or CSE last year, then you helped make that victory possible. Part of the victory is yours.

There are some negative thinkers who say that was only a small victory - only a slight change in rates with so much more to go. Let them reflect:

- \bullet To date, \$161 <u>million</u> in taxes has been shifted off the backs of building owners onto landowners by the efforts of your organization! This comes to over \$3,700 for every dollar contributed by our members!!
- Next year the figure will be much more, in part because we full expect to have more two-rate cities than the current five. Surely the negative thinkers are wrong. The dozen victories we've brought you in the past are truly significant.

Here surely is the way for us to get out of the Wilderness and into the Mainstream. Once our political leaders become acquainted with the construction upsurges which follow the adoption of the land value tax, then we could hope that they will jump on our Bandwagon, the idea will begin to spread, new cities will adopt the Two-Rate Incentive Tax, others will start on the way toward the Single Tax, and then we will be able to form a mass-membership organization, once our idea becomes a media-pushed public idea.

• And we are acquainting the politicians with these construction upsurges - see the enclosure and the Fortune article. Surely we would like to go faster, to skip some of the above steps, but if we want to make an impression in the Real World, we have to go one step at a time.

Our organization has been able to bring you Real-World Victories only because we visit politicians. How many more victories would come our way if we could hire a full-time salesman! The opportunities are out there, more than we can now handle. With your generous support, we can convert them into victories.
